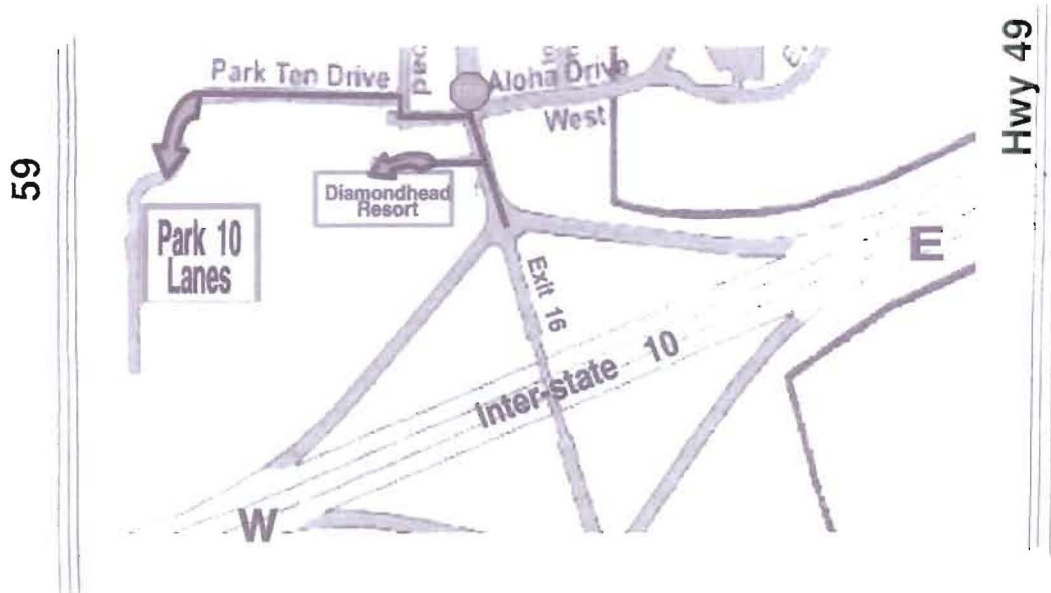

TOURNAMENT RULES

1. Entries will be scheduled on a FIRST COME FIRST SERVED Basis. The only exception to this will be the meeting weekend of May 22-23. Reserved entries for members attending the Annual Meeting must be received by March 1, 2010. Teams without a state Board Member or Delegate may request this weekend; however, they will be scheduled on this weekend only if lanes are available.
2. NO CELL PHONES, BEEPERS , FOOD OR BEVERAGE, OR TOBACCO PRODUCTS WILL BE ALLOWED IN SETTEE AREAS; your full cooperation will be appreciated.
3. To be eligible, a bowler must be a current member of MS STATE USBC BA and have a current average (minimum 21 games) in a Ms local association. All participants must display their USBC membership card or purchase an associate USBC membership card for \$21.00. Tournament and USBC Rules and Regulations will govern the Tournament.
4. Entrants will use their highest sanctioned winter (use summer, if no winter) league average (minimum 21 games) for the 2008-2009 season. If no 2008-2009 average, use highest current season average (minimum 21 games) as of April 1, 2010. USBC RULE319-e is waived for this tournament. Any entrant who has qualified for a prize of \$600.00 or more in any event in a sanctioned or non-sanctioned tournament within 12 months prior to March 31, 2010, even though prizes may not have been awarded, must report the amount, date won, scores and tournament name in writing to the tournament management , at time of entry for possible rerating (USBC RULE 319-d). If current average (mimumum 21 games) as of January 1, 2010 is 15 pins or more higher than 2008-2009 average, use January 1, 2010 average. It shall be each bowlers responsibility to verify the accuracy of the reported average on the entry form. PROFESSIONAL BOWLERS ARE LIMITED TO TWO PER TEAM AND ONE PER DOUBLES.
5. All prizes will be on handicap basis Except All Events Scratch. Handicap will be computed on a basis 80% of the difference between each average and 220. Maximum Handicap allowed per event is 180.
6. There will be one cash prize awarded for each eight entries (mimumum) except All Events Handicap and Scratch will be one for each ten entries (minimum). Suitable trophies or medals will be awarded to the winners in each event and to the sponsor of the winning teams. USBC AWARDS will be given to the Handicap and SCRATCH Champions in each event. In the event of ties, duplicate awards will be presented.
7. The schedule as indicated on the confirmation sheet must be adhere4d to: Should any entry fail to appear on time to bowl, the entry fee will be forfeited.
8. Substitutions are allowed , provided the Tournament Manager is notified at least 30 minutes before the scheduled time to bowl and the average of the substitute is certified. SUBSTITUTION IN ALL EVENTS IS NOT ALLOWED IF EITHER THE ORIGINALBOWLER OR SUBSTITUTE HAS ALREADY BOWLED IN THE TOURNAMENT.
9. MULTIPLE PARTICIPATION IS ALLOWED IN TEAM, DOUBLES, AND SINGLES EVENT. When a bowler competes more than once , in any event, the first appearance shall count toward All Events score. A bowler may enter both All Events Handicap and Scratch.
10. If required, additional shifts may be added, however, no shifts will be added beyond the last scheduled shift on May 30.
