# WOMEN'S 500 BOWLING CLUB OF MISSISSIPPI <br> RULES FOR 34th ANNUAL TOURNAMENT <br> DATES: SEPTEMBER 24 AND 25, 2022 

## TOURNAMENT RULES

1. USBC Sanctioned Tournament Rules and Regulations shall govern this tournament.
2. " 400 " and " 500 " handicapped tournament based on $90 \%$ highest average from 210.
3. All entrants must be members of their Local, State, USBC " 400 " and " 500 " Clubs. Unmarried, Grade, and High School Students who have not attained the age of 18 must furnish written consent signed by their parent or guardian on USBC approval form.
4. The " 500 " entry fee shall be $\$ 46.00$ (Lineage $\$ 21.00$, Prize Fund $\$ 18.00$, Expenses $\$ 3.00$, and Membership Fee $\$ 5.00$ ). " 400 " entry $\$ 42.00$ as they do not pay dues.
5. Participation shall be only one time in the Tournament of single events for six games, three on Saturday and three on Sunday, or six games on one of the two days.
6. Prize Fund will be returned $100 \%$. $\$ 10$ will be paid for High Game Scratch each day in both 400 and 500 Divisions.
7. Bowler's entering average will be:
a. Highest USBC average at the end of the 2020-2022 USBC winter League (yearbook) average based on 21 games or more. If no average bowlers will use a 210 average.
b. If no average from last year, use the highest average of the last two (2) years based on 21 games or more.
c. If no previous average, you may bowl scratch.
d. USBC rules 319a-2, 319d, and 319e does not apply, but 319a-3 does apply.
8. Failure to use the correct average shall disqualify score if submitted average is lower than correct average thereby resulting in a lower classification or more handicap. Prize winnings shall be based on the submitted average if it is higher than the current. However, corrections in averages may be permitted up to the completion of the first game.
9. Rule $324 \mathrm{~A}, \mathrm{~B}, \mathrm{C}$ applies provided the requirement of the tournament are met.
10. Check in time shall be 30 minutes before time to bowl. Membership card and USBC card must be shown.
11. Any bowler arriving late shall begin play and score counted beginning with frame being bowled. All previous frames will be " 0 ".
12. In case of a tie for first place, individuals tying shall divide $\$ 20.00$ Champion award, be declared co-champions, and total monies for the number of places tied will be distributed equally.
13. All entrants must sign the official score sheet. Any error or protest must be reported in writing within 24 hours.
14. The Tournament Director or Board of Directors shall decide any questions not covered by these rules.
15. Entry fee (draft, check or money order) must accompany application. Entries will be scheduled as received. Proper dress will be required.
